The annual Burning Man event started on San Francisco's Baker Beach in 1986. In 1990, it moved to the Black Rock Desert (BRD) and has been there since. BRD is about 1.5 hours outside of Reno, NV. In 2009, 44,000+ people showed up and in 2008, over 49,000+ people!

What Is Burning Man? Once a year, tens of thousands of participants gather to create Black Rock City in Nevada's Black Rock Desert, dedicated to community, art, self-expression, and self-reliance. They depart one week later, having left no trace whatsoever. Learn more about this incredible experience, read their mission statement and their Ten Principles.
